In accordance with Section 65 of The Canada

Corporations Act, it is provided that, when authorized by by-law,
duly passed by the Directors and sanctioned by at least twothirds of the votes cast at a special general meeting of the
members duly called for considering the by-law, the Directors

Nothing herein limits or restricts the borrowing of money by the Corporation on bills of exchange or promissory notes made, drawn, accepted or endorsed by or on behalf of the Corporation.

The by-laws of the Corporation shall be those filed with the application for letters patent until repealed, amended, altered or added to.

VIII. The Corporation is to carry on its operations without pecuniary gain to its members and any profits or other accretions to the Corporation are to be used in promoting its objects.
